Project Name: Tender for “Renovation/addition/alteration and new construction in existing Hospital and allied buildings including Civil & internal and external services like PHE, Electrical, HVAC etc. for Medical college at Regional Hospital at Chamba, District Chamba, Himachal Pradesh”.

This has reference to subject work, the following Amendment may be noted, which shall be treated as a part of the contract to be uploaded along with tender/ bid:

1. Contractor enlisted under Class-I composite category with CPWD upto tendering limit of Rs. 20 Crores are also eligible to participate in the tender and Clause no.1.4.1 (Eligibility Criteria) & 4.2 (Stage 1 –Technical Evaluation) of Vol.-I (NIT/PQ) shall not be applicable for such bidder. Accordingly such bidders are not to submit the following documents :
 - Form – L (Affidavit of bidder), Form – T1 (Financial Information), Form – T1’B (Solvency Certificate), Form – T2 (Details of works), Form – T3 (Project under execution of award), Form T-4 (Performance report of works).

The bidder should submit and upload copy of valid CPWD enlistment / registration certificate as Class-I contractor under composite category upto tendering limit of Rs.20 Cr. and requisite bid security as per bid documents.

2. Clause No. 1.4.1(i) (Bidding Capacity) & of Vol.-I (NIT/PQ) stands deleted for all bidders.
3. Regarding Service Tax: Rates/ Price to be quoted without service tax. Service tax as applicable, shall be reimbursed separately on submission of proof of deposition.
4. Form T-8 (Criteria for Evaluation of Performance) stands amended as enclosed at **Annexure – I**.

All other terms & Conditions of the Tender shall remain unchanged.

To become eligible for short listing, the bidder must secure at least 50% marks in each attribute and minimum 60% marks in aggregate.
