2. The validity of Bid Security/ Earnest Money Deposit (EMD) to be submitted by the bidders with their bid in the form of Bank Guarantee (BG) shall be considered from the original due date of bid submission i.e., from 22.10.2024.
3. Refer Cl. No. 2.0. “Minimum Eligibility Criteria” of Vol. I (NIT & PQ), definition of *Similar Work” is hereby amended and are as under :

<p>*Similar Work” shall mean Project comprising “Construction, Testing, Commissioning and Validation of Bio Safety Level-3/4 including Civil, HVAC, Electrical, PHE, Firefighting etc. works all executed under one composite agreement/work order.</p> <p>NOTE: a) BSL-3/4 works without civil works for construction of building shall not be considered as eligible similar works.</p>	<p>*Similar Work” shall mean "Establishment, Testing, Commissioning and Validation of Biosafety Level-3/4 works including HVAC, supply, installation works, all to be executed under one overall agreement/work order.”</p>
