1.0 SCOPE OF BID:

1.2 BRIEF DETAILS:

LGBRIMH intends to take up the work of “Construction of Residences, Hostels & Academic Buildings including PHE, Electrical, HVAC, Fire fighting, & other internal & external services in (LGBRIMH) Post Box NO.15, Tezpur, Assam” through its consultant i.e HSCC (India) Ltd. 1.3 Pre-Qualification & tender is open to all the firms having sound financial background and experience of successfully executing the project of similar nature and magnitude.

2.0 SUBMISSION OF APPLICATION:

- 2.2 The name and mailing address of the Applicant should be clearly marked on the envelope.
- 2.3 All the information asked for pre-qualification and tender shall be answered in the ENGLISH language by all the agencies/firms.
- 2.4 Failure to provide information in the stipulated format enclosed or to provide timely clarification or substantiation of the information supplied (considered essential to evaluate the Applicant's qualification) may result in disqualification of the Applicant.

3.0 MINIMUM CRITERIA FOR PRE-QUALIFICATION:

3.1 Pre-qualification will be based on meeting the following criteria regarding the Applicant's work experience, personnel and equipment capabilities, and financial position, as demonstrated by the Applicant's responses in the forms attached to the Letter of Application and proof of registration with statutory bodies.

3.2 The Applicant should meet the following minimum criteria for pre-qualification:

(a) Average annual financial turnover during the last three consecutive financial years [2008-2009, 2009-2010 & 2010-2011] should be at least 30% of the estimated cost.

(b) Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which application are invited should be either of following :

Three *similar completed works each costing not less than the amount equal to 40% of the estimated cost

or

Two *similar completed works each costing not less than the amount equal to 60 % of the estimated cost.

or

One *similar completed work costing not less than the amount equal to 80 % of the estimated cost.

(c) One completed work of any nature (either part of (b) or a separate one costing not less than the amount equal to 40% of the estimated cost with some central/ state Government organization/ / Central Autonomous body/ Central Public Sector Under taking

(d) A solvency certificate from applicant's bank (Nationalized/ Scheduled) that applicant is solvent for the sum of 40% of the estimated cost. The certificate should not be more then six months old.

(e) The Company should have positive Net Worth and should not have incurred loss in more than Two years in last Five years ending 31st March 2011 duly certified by the Chartered Account.

(f) **"Similar work"** shall mean completion of a Project comprising Construction of RCC framed structure (G+4 Building) including Civil, Electrical, HVAC, Plumbing, internal and external services, Lift, DG set, firefighting etc in 24 (twenty four) months time. However, In case the bidder does not have the experience of specialized works

such as fire fighting, Lifts, Electrical, DG Set, HVAC, etc. such specialized works shall be carried out by specialized agencies having sound financial background and experience of executing works of similar nature & magnitude. The bidder is required to give an undertaking as per enclosed format at Annexure- VII in respect of specialized agency for execution of specialized works.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at a simple rate of 7 % per annum, calculated from the date of completion to last date of receipt of application for Prequalification.

A Certificate from client for completion of work(s) must be submitted along with application. Own works / own certification of the agencies shall not be considered for prequalification.

- g) The bidding capacity of the bidder should be equal to or more than the estimated cost of work put to tender. The bidding capacity shall be worked out by the following formulae.

Bidding Capacity = (AXNX2)-B

A= Maximum value of construction works executed in any one year during the last five years taking into account the completed as well as works in progress.

N= Number of years prescribed for completion of works for which bids has been invited.

B= Value of existing commitments and ongoing works to be completed during the period of completion of work for which bids have been invited.

- 3.3 **Personnel Capabilities** : The firm should have suitable qualified and experienced personnel for the successful completion of the works. List of employees along with their qualification & experience of key officials shall be submitted stating clearly how these would be involved in this work. (Fill enclosed ANNEXURE - II).
- 3.4 **Equipment Capabilities** : The Applicant should provide an undertaking regarding availability of equipments required for the completion of the project along with list of equipments indicating owned or to be hired. In case equipments are to be hired then source of equipments may also be indicated. (Fill enclosed ANNEXURE - III).
- 3.5 **Financial Capabilities** : The Audited Balance Sheets for the last five financial years (2006-07, 2007-08, 2008-09, 2009-10, 2010-11) should be submitted and must demonstrate the soundness of the Applicant's financial position showing positive net worth and net profit see ANNEXURE-V). Where necessary, the Consultant (HSCC) on behalf of Employer will make inquiries with the Applicant's bankers (Applicant to fill enclosed ANNEXURE-IV)
- 3.6 The firm should submit an affidavit duly notarized that they have not abandoned any work of Union Government/ State Governments/ PSU's etc. during the last 5 years. They should also submit an affidavit that they have not been blacklisted, debarred, declared non performer or expelled by Union Government/ State Governments/ PSU's etc. during the last 5 years.
- 3.7 The applicant should provide information regarding litigation/ Arbitration cases for the last five years as per ANNEXURE- V

3.8 The bidder shall submit the supporting documents regarding the information given in the ANNEXURE - I to ANNEXURE - V.

3.9 Evaluation Criteria

3.9.1 The bidders qualifying the initial criteria as set out in para 3.2 above will be evaluated for following criteria by scoring method on the basis of details furnished by them (Refer Annexure-IX).

To become eligible for short listing the bidder must secure at least 50% marks in each and 60% marks in aggregate.

LLGBRIMH/HSCC reserves the right to restrict the list of such qualified Contractors to any number deemed suitable by it.

3.10 Even though the applicants meet the above criteria, they are subject to be disqualified if they have:

- (a) made misleading or false representation in the form, statements and attachments submitted; in proof of the qualification requirements, and for
- (b) record of poor performance such as abandoning the work, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures, etc. and

The applicants are also subject to be disqualified, if they are found to be black listed in any of the works.

3.11 The applicants are advised to visit the site to get first hand information as regards its approach, accessibility, working conditions, site conditions, availability of labour and material etc. and other matters affecting cost and work. All costs incurred in connection with submission of the pre qualification bid shall be borne by the applicant irrespective of the outcome.

3.12 Registration / Licence : The firm should have registration with the appropriate authorities for the Works Contract Tax , VAT, ESI, PF if applicable. In case the firm is not registered at the time of submission of bid, they will submit an undertaking that they will get themselves registered with the concerned authorities in case they are awarded the work.

3.13 If any information furnished by the applicant is found incorrect at a later stage, applicant shall be liable to be debarred from tendering in HSCC/LGBRIMH. The department reserves the right to verify the particulars furnished by the applicant independently.

3.14 The competent authority to pre-qualify shall have the power to relax any condition/criterion for pre-qualification if it considers expedient to do so

4.0 GENERAL

4.1 Only contractor / firms whose bid is found to be generally in order, meets the prequalification criteria and substantially responsive shall be opened either at the Bid opening or at a subsequent date to be intimated in advance to such eligible Bidders.

4.2 The Employer / Consultant reserve the right to:

- (a) Reject or accept any application without assigning any reason or incurring any liability thereof
- (b) Cancel the pre-qualification process and reject all applications
- (c) Split the works into different packages if required
- (d) Amend the scope and value of any contract under this project, in such event the bids will only be called from those pre-qualified applicants who meet the requirements of the contract as amended.
